Indemnification. Permittee assumes all responsibility, risk and liability for all activities of the permittee, its employees, agents, invitees, contractors, subcontractors, or licensees, directly or indirectly conducted in connection with this Agreement...

Insurance. Without limiting its indemnification, and prior to making use of the facility, it is agreed that the Permittee shall purchase at its own expense, and maintain in force at all times during the term of this Agreement, commercial general liability insurance...

Failure to furnish satisfactory evidence of insurance, lapse of a policy, or inadequate limits, is grounds for termination of this Agreement. All insurance should be issued by companies admitted to do business in the State of Alaska...

Vandalism. During the periods of facility use by the Permittee, Permittee shall be responsible for vandalism or damages occurring during its use and shall be responsible for the expense of repairs.

Additional Services. Permittee shall reimburse UA for any and all services not included in this Agreement but requested by Permittee or required to fulfill Permittee's responsibilities under the terms of this Agreement.

Assignment. No benefit under this Agreement may be assigned nor may any duty under this Agreement be delegated without the written consent of the other party.

Termination. This Agreement may be terminated by either party in the event of non-performance by the other.

Interpretation. This Agreement constitutes the entire agreement between the parties, superseding all previous representations, discussions, and agreements between the parties. This Agreement shall be binding upon and shall inure to the benefit of the successors and, subject to the provisions relating to assignment, the assigns of each of the parties.

Notices. Any notices concerning this Agreement and all notices required by this Agreement shall be given in writing and shall be personally delivered or mailed to the addresses designated by the parties below.
