TERMS AND CONDITIONS OF FINANCIAL AID OFFER

1. Federal, state and university financial aid programs require:
 - official admission into a degree or certificate program. You can apply at www.uas.alaska.edu/apply.
 - satisfactory academic progress. Refer to your academic catalog or visit the SAP page at uas.alaska.edu/finaid/sap.html. Current students may review their standing at UAOnline at www.uaonline.alaska.edu.
2. Your costs of attendance and aid eligibility are based on your reported status for a number of items. Report to the Financial Aid Office status changes for:
 - your housing plans;
 - your enrollment load or residency;
 - receipt of additional resources not stated in this offer; or
 - when you graduate, withdraw or cease to be at least a half-time student.
3. Loans are funds that must be repaid. Grants and scholarships are gifts that are not repaid.
4. By accepting this offer of financial aid, you understand and agree to:
 - accept responsibility for repayment of any loans you borrow;
 - certify that you do not owe a refund on any education grant or loan, are not in default on any education loan, and have not borrowed in excess of the loan limits under the Title IV programs; and
 - use all Title IV money received only for expenses related to your study at the University of Alaska Southeast.
5. All unpaid tuition, fees, housing charges, and other university debts will be deducted from your financial aid before any balance will be disbursed to you. If you are a continuing student or have already registered, you can review charges already incurred on UAOnline at www.uaonline.alaska.edu. Your student account will not reflect future financial aid disbursements.
6. Timelines: The priority application deadline for admission to a degree program is August 1 for the fall semester, and December 15 for the spring semester. Your award acceptance form should be accepted within 14 days of the date of the award letter to ensure FSEOG grant and scholarship availability. Loan offers may be accepted any time during the academic year. However, because loan processing takes approximately 1-3 weeks from the time the Financial Aid Office receives your award acceptance, loan offers should be accepted at least 3 weeks prior to the end of the academic year.
