Examples of supporting documentation include: several months' bank statements; a letter from an employer stating period of employment, planned continued employment and a yearly salary; or a U.S. Immigration Form I-134 Affidavit of Support (for students who have a financial sponsor in the United States). All documents must be officially translated into English and the monetary amounts expressed in U.S dollars. Student need to keep a duplicate set of all documentation, the duplicate set will be necessary to apply for a visa and to enter the United States.

Undergraduate resident tuition is approximately \$6,360 and graduate tuition is approximately \$7,992 for the nine month academic year.
