Application for Placement Testing Fee Waiver Information

Placement Testing fee waivers are considered on a case by case basis. All waiver application forms must be accompanied by supporting documentation. All documentation will be used for eligibility verification only and will not be retained. Documentation presented in person will be returned. Any documentation mailed, faxed, or submitted electronically will be reviewed and shredded or electronically deleted.

Approved applicants will be notified by email or in person.

The following are acceptable forms of eligibility documentation:

- ACT or SAT Exam Fee waivers for current high school seniors received from their school's counseling office.
- A copy of your current Section 8 Housing Voucher or Public Assistance eligibility letter or any other form of official verification of assistance.
- Letter of status as a current or recent ward of the state or in the foster care system from the State of Alaska Office of Children's Services.
- Previous year's tax returns showing the yearly household income and number of household members.
